CHARACTERISTICS

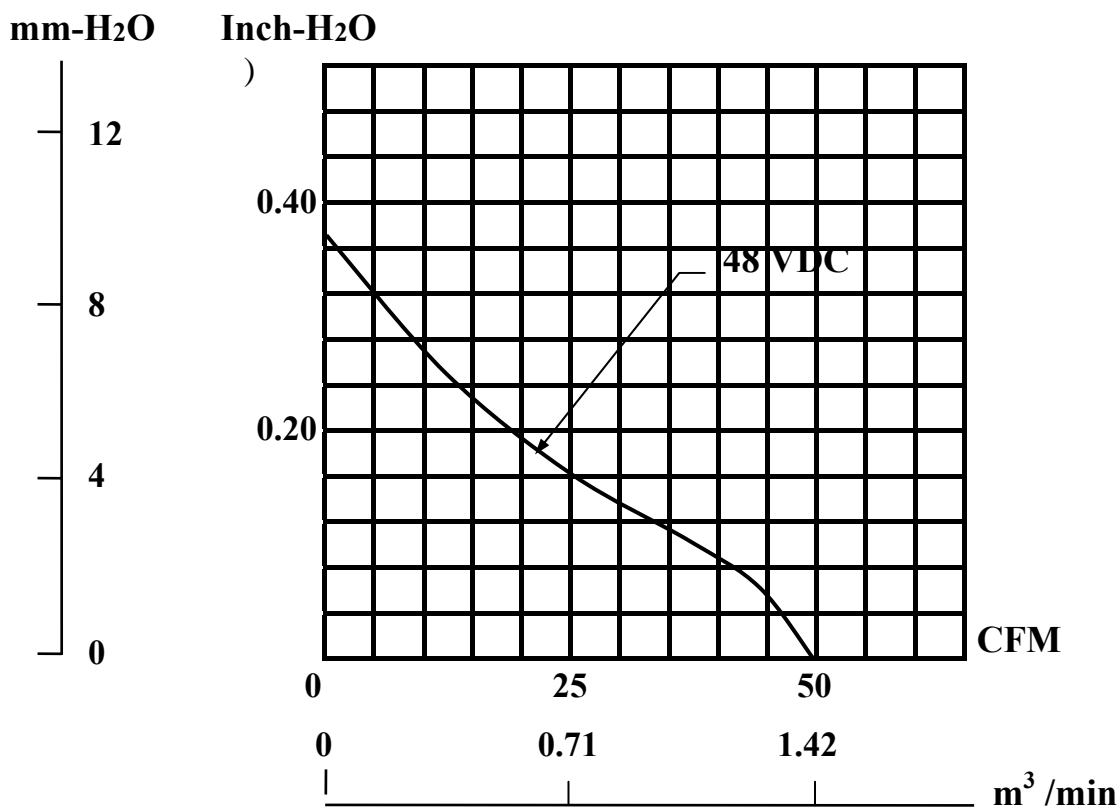

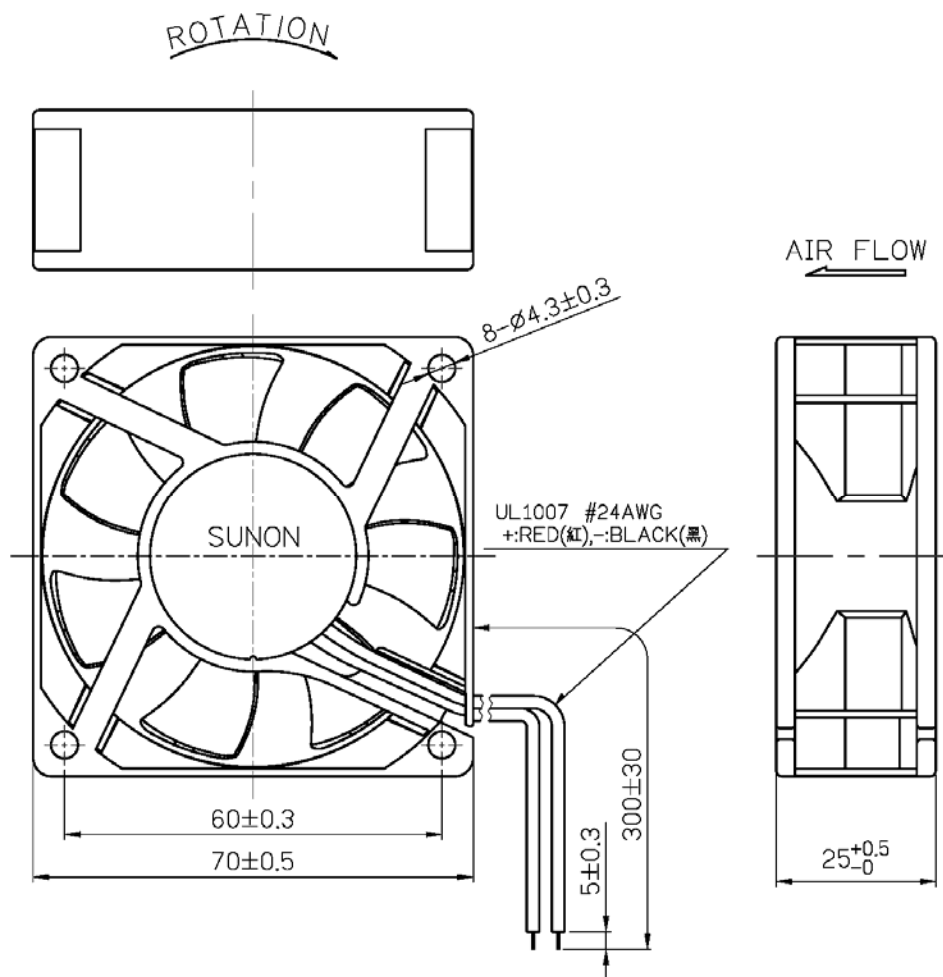
